**CLASS RULES and REGULATIONS**

Registration Policy- All students (the "Student") must pay a \$25 registration fee at the beginning of each 12-18 week session.

Payment Policy- Acceptable forms of payment are cash, checks or money orders made payable to M.A.D.E. Today. Parents and Guardians (the "Parents") who intend to pay by check must complete a check information form.

One month payment is due at time of registration along with registration fee. Payments are due the first practice of each and every month.

A late fee of \$10 per week will be assessed for all late payments.

Bounced Check policy- If a Parent bounces a check there will be a \$25 fee. The Parent will receive a verbal and/or written notice that their check bounced and the check will be re-submitted within 14 days. Parent's account will become cash only if there has been two consecutive bounced checks.

Bounced checks which remain unresolved for sixty days will be forwarded to collections for immediate legal action.

Students will not be allowed to participate until all accounts are settled.

All class fees, uniform fees and payments are **non-refundable**.

Withdrawal Policy - Parents are required to give the Director 30 days notice if they intend to withdraw the Student from the session. Parents must complete and sign a withdrawal form which will detail the date that notice was given, the date of the student's last class, and an accounting of monies due.

Spectators Policy- Parents and/or siblings or guests will not be permitted to enter the practice area until the last five minutes of the session.

Practice Attire Policy - Students must wear black or pink leotards with black or pink bottoms to each practice without exception, unless other attire is provided by MADE.

Missed Practice Policy

Unexcused Absence - If the Student misses a practice without an excuse, even with notice, the Student must attend a make-up class and pay an additional \$10 make-up fee.

Excused Absence - If the Student must miss a class for an excused purpose (i.e.: a school function or an illness) and visits another site to make up the class within that week the absence is excused and there will be no charge for attending the class at another site.

The decision regarding whether a missed class is an excused absence or an unexcused absence shall be solely within the discretion of the Director.

Photo Release- Parents hereby give permission, without limitation or obligation, for the Student to be photographed or videotaped in relation to their participation at class or programs. Photographs and videotape may be used for archival or promotional purposes.

Indemnification and Liability-

Parents are aware of the risks involved, assume all risks for Students' participation in the Program and do hereby release, indemnify and hold harmless M.A.D.E. Today, its organizers, sponsors, administrators and instructors from and against any and all liability of any nature whatsoever arising out of, incident to or in any way connected with the Student's participation in the Program.

Should an accident occur and the student files suit, Parent agrees to resolve the matter through binding arbitration.

In the event of an injury, accident, illness or other mishap incident to the Program, Parent gives permission for the student to be treated by a licensed physician or representative of M.A.D.E. Today, its organizers, sponsors, administrators and instructors.
